Introduction

You need a web browser to start it.

The Registry application is a web application.

Step by step

Execute the following steps to start the application:

Login and Logout

Introduction

Visitors who want to follow-up on ETS news, look at public reports or create an account can do so without a login.

Users who want to work with the application need to log into the Union Registry. This is a safe and restricted environment where only authenticated users can have access to some non-public information and features. Note that you need to have an EU Login user account to authenticate and log into the application. Refer to the procedure "Create an EU Login user account" on page 3 for more information.

EU Login verification method change As of release 11 of the Union Registry, the "EU Login Mobile App QR Code" method (the socalled Soft Token method) is made available to the Union Registry users to login and sign operations.

To ensure a gradual and smooth transition to the new verification method, it is still possible to authenticate and sign with GSM/SMS verification method for a defined period.

<u>However, please note that, once you login using the EU Login Mobile app, you will not be</u> <u>able to use the GSM/SMS verification method anymore.</u>

<u>Furthermore, once the transition period is over (i.e. after cut-off date), it will not be</u> <u>possible to use the GSM/SMS verification method anymore.</u>

Create an EU Login user account

Introduction

EU Login is the name of the European Commission Authentication Service, a platform used by multiple website applications to authenticate users.

This procedure describes how to create an EU Login user account.

Step by step to create your Eu Login account To create a user account, execute the following steps from the Application home page:

The Union Registry requires the use of the EU Login Mobile app to authenticate and sign

When a mobile device is successfully added to an EU Login account, it generates a MUDI (Mobile Unique Device Identifier) used by the Union Registry to authenticate you.

For this reason, a mobile device can only be linked to one EU Login account and one user can log into the Union Registry with one mobile device only.

Furthermore, if you reinitialise your EU Login Mobile app and add it again to your EU Login account, it will generate a new MUDI, even if it is the same mobile device.

When trying to log into to the Union Registry after generating the new MUDI, the system will ask you to choose between logging in with the mobile device previously registered, or change to the new mobile device. After the change has been approved by a National Administrator, you will be able to log in again to the Union Registry.

¹ For security reasons, this option is disabled if you do not have any security measure (PIN, unlock pattern, fingerprint or face recognition,...) configured in your smartphone



Add a mobile phone number to your EU Login account

Introduction The Union Registry requires the use of the EU Login Mobile app to authenticate and sign processes.

However, you still need to register a mobile phone number as a fallback solution.
